RULES AND NOMINATION FORM

ENTRY FEES:

\$30 per horse & rider

Non-AFTER Members must also pay a \$30.00 day insurance levy

RULES & CONDITIONS

1. The event is open to all purebred and part-bred Standardbreds.
2. Pare-bred Standardbreds must have proof of breeding submitted with nomination.
3. No fresh nominations will be accepted on the day.
4. One rider/ handler per horse rule will apply.
5. Competitors who are not current financial members of AFTER must pay a \$30 day insurance fee with their nomination.
6. Champion & Reserve Champion will be calculated using a points system as follows:
1st – 7
2nd – 5
3rd – 4
4th – 3
5th – 2
6th – 1
7. Formal Classes will be conducted under *AFTER's Showing and Judging Guidelines*, copies of which can be downloaded from www.afterqld.org.au or by contacting AFTER at (07) 5467 9571 or info@afterqld.org.au
8. Stallions must be handled/ ridden by a handler 18 years or over.
9. A **beginner** horse is one which has not won two or more first placings, or a combination of first placings and champions, in a beginner ridden or any ridden Standardbred class where there was more than one horse in the class.
10. A **novice** horse is one which has not won three or more first placings, or a combination of first placings and champions, in a novice ridden or any ridden Standardbred class where there was more than one horse in the class.
11. **Beginner and Novice horses must be shown in a snaffle bit only** – no chains, pelhams or double bridles will be accepted.
12. **Pleasure hack** - To be ridden one handed with snaffle bit. No noseband, whips or spurs.
13. EFA standard footwear & head protection must be worn; helmets must comply with EFA rules. **NO HELMET, NO RIDE – NO EXCEPTIONS.**
14. An insurance waiver must be signed and submitted before the start of the event.
15. Bad language, inappropriate behaviour or abuse of officials, volunteers, other competitors or spectators will not be tolerated.
16. Abuse of horses will not be tolerated.
17. No dogs allowed on grounds.
18. All horses must present for competition drug free.
19. The organisers reserve the right to vary the time & sequence of events in the program & to refuse or cancel any entry without giving any reason to do so & no claims shall be made against the organisers by reason of any such refusal or cancellation.
20. Competitors who disobey these rules may be disqualified from the entire event without refund of entry fees.

PROTESTS

21. Protests must be submitted within 30 minutes of the incident occurring and a \$50– fee will apply (refunded if protest is upheld).
